

# Sun Ninja Setup Instructions

## STEP 1: LAY OUT THE TENT

Pick your spot. Unpack your Sun Ninja. Stretch it out on the ground. **The “front” of the tent must always face into the wind!**



## 2. FILL CORNER SANDBAGS WITH SAND

Fill the corner sandbags (completely) with lots of sand, to secure your Sun Ninja properly to the beach. More wind means more sand!



## STEP 3: SETUP POLES

Slot your poles segments together to make a whole. **Always make sure to set up the tent AGAINST the wind!** Prop up the corners of your tent with the “ball end” at the top.



## STEP 4: ENJOY UPF 50+ PROTECTION



Now roll out a towel and enjoy the shade with UPF50 protection!
